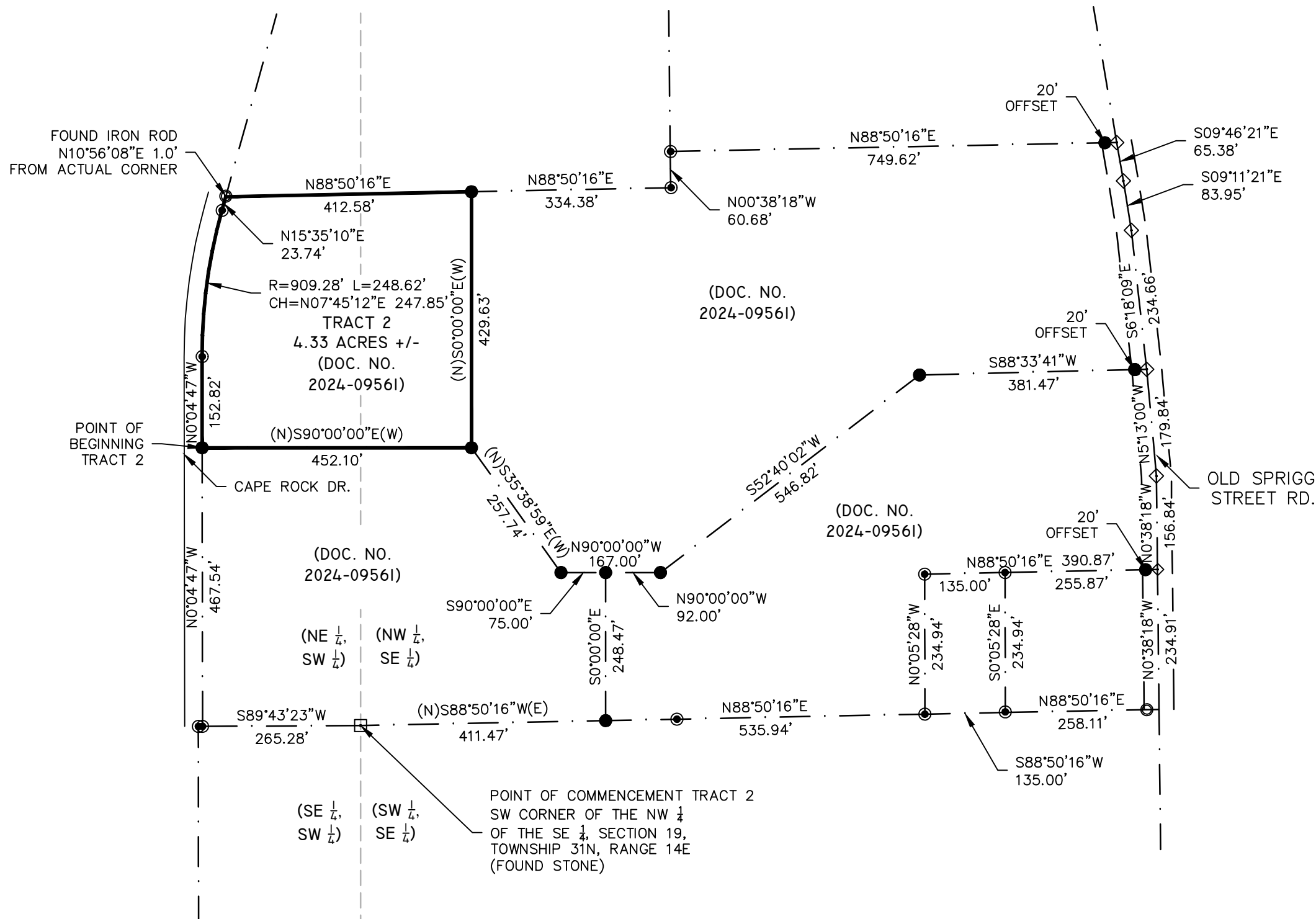

TRACT 2 - DESCRIPTION

THAT PART OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER, AND THAT PART OF
THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER, ALL IN SECTION 19, TOWNSHIP 31
NORTH, RANGE 14 EAST OF THE FIFTH PRINCIPAL MERIDIAN, CAPE GIRARDEAU COUNTY,
MISSOURI, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

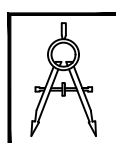
COMMENCE AT THE SOUTHWEST CORNER OF SAID NORTHWEST QUARTER OF THE SOUTHEAST
QUARTER OF SAID SECTION 19; THENCE SOUTH 89°43'23" WEST ALONG THE SOUTH LINE OF
SAID NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 19, 265.28 FEET
TO A POINT ON THE EAST RIGHT OF WAY LINE OF CAPE ROCK DRIVE; THENCE LEAVING SAID
SOUTH LINE, NORTH 00°04'47" WEST ALONG SAID EAST RIGHT OF WAY LINE, 467.54 FEET TO
THE POINT OF BEGINNING.

THENCE FROM THE POINT OF BEGINNING, CONTINUE NORTH 00°04'47" WEST ALONG SAID
EAST RIGHT OF WAY LINE, 152.82 FEET; THENCE CONTINUE ALONG SAID EAST RIGHT OF WAY LINE,
ALONG A CURVE TO THE RIGHT, HAVING A RADIUS OF 909.28 FEET, FOR AN ARC LENGTH OF
248.62 FEET (THE CHORD OF SAID ARC BEARS NORTH 07°45'12" EAST 247.85 FEET); THENCE
CONTINUE ALONG SAID EAST RIGHT OF WAY LINE, NORTH 15°35'10" EAST 23.74 FEET; THENCE
LEAVING SAID EAST RIGHT OF WAY LINE, NORTH 88°50'16" EAST 412.58 FEET; THENCE SOUTH
00°00'00" EAST 429.63 FEET; THENCE NORTH 90°00'00" WEST 452.10 FEET TO THE POINT OF
BEGINNING.
